Independent Auditors' Report

To the Board of Directors United Way of Westchester and Putnam, Inc.

We have audited the accompanying statements of financial position of United Way of Westchester and Putnam, Inc. ("United Way") as of June 30, 2008 and 2007, and the related statements of activities, functional expenses and cash flows for the years then ended. These financial statements are the responsibility of United Way's management. Our responsibility is to express an opinion on these financial statements based on our audits.

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free of material misstatement. An audit includes consideration of internal control over financial reporting as a basis for designing audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of United Way's internal control over financial reporting. Accordingly, we express no such opinion. An audit also includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements, assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall financial statement presentation. We believe that our audits provide a reasonable basis for our opinion.

In our opinion, the financial statements referred to above present fairly, in all material respects, the financial position of United Way of Westchester and Putnam, Inc. as of June 30, 2008 and 2007, and the changes in its net assets and its cash flows for the years then ended in conformity with accounting principles generally accepted in the United States of America.

Our 2008 audit was made for the purpose of forming an opinion on the basic financial statements taken as a whole. The supplementary schedules on pages 20 through 29 are presented for purposes of additional analysis and are not a required part of the basic financial statements. Such schedules have been subjected to the auditing procedures applied in the audit of the basic financial statements and, in our opinion, are fairly stated in all material respects in relation to the basic financial statements taken as a whole.

Notes to Financial Statements

1. The Organization

United Way of Westchester and Putnam, Inc. ("United Way") is a local, independent not-for-profit health and human services agency exempt from Federal income taxes under Section 501(c)(3) of the Internal Revenue Code. United Way's mission is to achieve the common good by creating opportunities for every person within our community to have a better life. United Way is focused on helping everyone receive a quality education which leads to a stable job until retirement and good health.

Volunteers and staff work together to manage the United Way. This work includes assessing the needs of the community, developing strategies to meet the most critical needs, raising resources and funding initiatives to implement these strategies and communicating the results back to the community.

Some of the communities within this United Way conduct fund-raising, communication and volunteer recruitment activities in the name of geographically smaller areas that are within Westchester County. These "local community United Ways" function as local affiliates of United Way of Westchester and Putnam. Some of these local affiliated United Ways continue to maintain separate legal status and retain non-campaign receipts and title to reserve funds which are not included in these Financial Statements.

The United Way has responsibility for soliciting, billing, and collecting all local donors' accounts. Amounts collected on behalf of other not-for-profit agencies that have been designated by the Internal Revenue Service as exempt under Section 501(c)(3) are distributed as prescribed by the donor. In addition, the United Way is a participant in a regional campaign managed by United Way of America which was created to coordinate fundraising for companies with employees in multiple locations, on behalf of autonomous local United Ways in New York, New Jersey and Connecticut. The United Way of America regional office in New York City has assumed coordination and collection responsibilities for these companies within the Tri-State area. Each United Way participating in the regional campaign takes an active role in working with those companies in their area and shares in the unrestricted funds raised in accordance with a distribution formula that is explained in a Memorandum of Agreement which has been signed and accepted by the United Way of Westchester and Putnam's Board of Directors in 2008.

2. Significant Accounting Policies

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. The most significant estimates and assumptions relate to the determination of the allowance for uncollectible pledges and accrued pension cost. Actual results could differ from those estimates.

2. Significant Accounting Policies (*continued*)

Financial Statement Presentation

Net assets and revenues and expenses are classified based on the existence or absence of donor-imposed restrictions. Accordingly, net assets and changes therein, are classified and reported as unrestricted net assets, temporarily-restricted net assets and permanently-restricted net assets, as applicable.

Cash and Cash Equivalents

Cash includes currency on hand, demand deposits with financial institutions, and other amounts that have the general characteristics of demand deposits. Cash equivalents include short-term investments with maturities of three months or less at the time of purchase.

Investments

Investments consisting of debt and equity securities are reported at fair value and unrealized gains and losses are included in the statement of activities. Fair value was determined principally by reference to quoted market prices.

Land, Building and Equipment

Land, building and equipment is stated at cost at the date of acquisition or at estimated fair market value at the date of donation, less accumulated depreciation. Expenditures for land, buildings and equipment in excess of \$500 are capitalized. Depreciation is calculated using the straight-line method over the estimated useful lives of the assets as follows: buildings (25 years); capital improvements (5 to 10 years); and furniture, fixtures and equipment (3 to 10 years).

Campaign Results

Funds raised by United Way are categorized as follows:

- Unrestricted local campaign pledges.
- Local campaign pledges restricted by donors (referred to as donor choice).
- Share of Tri-State Regional Campaign as determined by agreed upon formula.
- Proportionate share of Tri-State Regional Campaign's pledges restricted by donors to agencies and United Ways not participating in Regional Campaign (referred to as donor choice).

Amounts raised on behalf of others includes United Way's share of the Tri-State Regional Campaign restricted pledges and local campaign restricted pledges (referred to as donor choice).

2. Significant Accounting Policies (*continued*)

Contributions

Contributions are recognized when the donor makes a promise to give that is, in substance, unconditional. Contributions received are recorded as unrestricted and temporarily-restricted support depending on the existence and/or nature of any donor restrictions. When a restriction expires, temporarily restricted net assets are reclassified to unrestricted net assets. The Regional Campaign promises receivables are recorded when the United Way is notified of final results by the regional office or through the United Way that has been deemed the organization that conducted a workplace campaign on behalf of the regional campaign. The United Way uses the allowance method to determine uncollectible unconditional promises receivable. The allowance is based on prior years' experience and management's analysis of specific promises made.

Contributed Materials and Services

Contributed materials are reported at fair value on the date of donation. A substantial number of volunteers have donated considerable amounts of their time to the United Way's program and supporting services; however, no contributed services met the requirements for recognition in the financial statements. It is United Way of America's policy to recognize the value of volunteer services by using the value established by the Independent Sector at \$18.77 per hour. Utilizing this calculation for the year ended June 30, 2008, United Way of Westchester and Putnam has determined that \$76,206 was contributed in services time to our United Way.

Allocations and Designations to Agencies

In June 2008, the Board of Directors of United Way approved an initial budgeted amount of \$1,014,272 in undesignated and targeted funds for allocations and grants in fiscal 2008. No liability has been recorded in the accompanying financial statements because the distributions will be funded from the proceeds of the 2008-2009 fundraising campaign conducted in fiscal 2009.

Amounts which have been allocated to specific agencies in the current fiscal year but have not been disbursed as of June 30 are accrued and reflected in the accompanying statements of financial position as "Due to Agencies". Amounts committed for periods after year end are subject to further review and approval by the United Way Board and the availability of funding. Accordingly, such amounts are not reflected as a liability as of year end. Donor choice funds are paid separately, generally on a quarterly basis, and have also been reflected in "Due to Agencies".

3. Concentrations of Credit Risk

Financial instruments which potentially subject United Way to concentrations of credit risk include bank deposits in excess of the Federal Deposit Insurance Corporation ("FDIC") limits. United Way management believes it mitigates its risk by investing with reputable commercial institutions with satisfactory credit ratings. United Way has not experienced any losses on these financial instruments.

Campaign results include funds raised by the Tri-State Regional Campaign which represents approximately 28% and 43% of the total for fiscal 2008 and 2007. A significant change in the relationship with the Regional Campaign could have a material impact on United Way's operations.

7. Other Assets (continued)

United Way has a beneficial interest in the Ruth Taylor Award Fund, a charitable trust, which is not in the United Way's possession or under its control. The fund was established by Nelson Rockefeller in 1951 and contained restrictions on the use of the income. In 2007, the New York State Attorney General's Office notified the United Way that it was the legal successor of the fund. Generally accepted accounting principles require the recognition of the fair value of the future income stream from the fund. The fair value of the underlying assets of the fund was used to determine the future income stream. The assets of the trust are classified as temporarily and permanently restricted.

United Way is also the beneficiary of two charitable gift annuities. Upon death of the owners, United Way will receive the gifts from the annuities. The administrator of the annuities is United Way of America.

8. Loan Payable to Bank

The United Way has a \$1,700,000 collateralized open ended line of credit from a financial institution. Outstanding borrowings bear interest at either the institution's rate (the higher of prime or the federal funds rate plus 1/2%), or the London Interbank Offer Rate (LIBOR plus 1.75%). The agreement requires the line be repaid to a minimum of \$700,000 for a period of 30 days annually. The line of credit is collateralized by United Way's present and future undesignated receivables as well as a \$1,000,000 lien on the building. Interest expense incurred was \$87,492 and \$85,785 in fiscal 2008 and 2007.

9. Pension Plan

United Way maintains a noncontributory defined benefit pension plan covering substantially all of its employees. Effective July 1, 2007, United Way adopted the recognition and disclosure provisions of Statement No. 158. Statement No. 158 required the United Way to recognize the funded status of its pension plan in the June 30, 2007 statement of financial position, with a corresponding adjustment to other changes in net assets. The adjustment to other changes in net assets at adoption represents the balance of unrecognized obligation that will be recognized within net periodic pension costs in the future. The incremental effects of adopting the provisions of Statement No. 158 resulted in a charge to net assets and an increase in accrued pension cost totaling of \$223,808 as of June 30, 2007.

The Expected Long-Term Rate of Return on Plan Assets assumption of 7.5% was selected using the "building block" approach described by the Actuarial Standards Board in Actuarial Standards of Practice No. 27 - Selection Economic Assumptions for Measuring Pension Obligations. Based on United Way's investment policy for the pension plan in effect as of the beginning of fiscal year, a best estimate range was determined for both the real rate of return (net of inflation) and for inflation based on historical 30-year period rolling averages. An average inflation rate within the range equal to 3.75% was selected and added to the real rate of return range to arrive at a best estimate range of 6.49%-8.71%. A rate close to the midpoint of the best estimate range of 7.5% was selected.

12. Westchester Nonprofit Loan Fund

The Loan Fund is a collaboration of United Way, The Westchester Community Foundation, The Volunteer Center of United Way and The Westchester County Bankers Association. The mission of the Loan Fund is to provide secured loans and loan-related technical assistance to nonprofit agencies which provide direct services to the residents of the County. United Way acts as fiscal agent for the Loan Fund and all assets, liabilities and activity are included in the financial statements.

During fiscal 2007, the Loan Fund borrowed a \$125,000 interest free recoverable grant which is reflected as an investment and a payable in the statement of financial position. In February 2008, the Loan Fund repaid this grant. The net assets of the Loan Fund amounted to \$141,595 and \$129,096 at June 30, 2008 and 2007, which consisted of \$76,595 and \$64,096 of Board-Designated net assets and \$65,000 of Permanently-Restricted Net Assets for Capital Grants.

13. 2-1-1 Hudson Valley Region

United Way of Westchester and Putnam brought together the other United Ways in the Hudson Valley region (Dutchess, Orange, Putnam, Rockland, Sullivan, Ulster and Westchester) to develop and maintain a 2-1-1 service, which enables those in need to call an easy-to-remember 3-digit telephone number to reach trained information and referral specialists who through a comprehensive database, are able to connect callers to health and human services that can assist them.

United Way is the fiscal and operating agent for 2-1-1 Hudson Valley Region which is being underwritten by local United Ways, governments and foundations. Net assets of the 2-1-1 Hudson Valley Region at June 30, 2008 and 2007 amounted to \$83,547 and \$105,539.

14. Other Transactions

During fiscal 2008 and 2007, United Way acted as the Principal Combined Fund Organization ("PCFO") for the Taconic Valley Combined Federal Campaign ("CFC"), which was formed by the combination of the Westchester-Putnam CFC and the Dutchess Ulster CFC. During 2008 and 2007, the CFC had expenses totaling \$45,413 and \$42,964, for campaign and administrative support provided by the United Way. The pledge receivable from the CFC was \$6,132 and \$9,311 as of June 30, 2008 and 2007.

The present value of capital lease obligations are included in other liabilities in the statement of financial position. Additionally, United Way leases office space under noncancelable operating leases with terms which include utilities, property taxes and maintenance, and extend through fiscal year 2009. Annual commitments total \$26,127 in fiscal year 2009. Rental expense and other equipment expenses were \$50,881 and \$52,404 in fiscal 2008 and 2007.

16. Emergency Food and Shelter Program

Each year, the United States Congress appropriates funds for an emergency food and shelter program which is administered by a national board involving nine major not-for-profit organizations, including the United Way of America. In turn, local emergency food and shelter boards, involving local representatives of the nine organizations, including local United Ways and other local public and community leaders, recommend how local shares of the total appropriation, based on several needs-oriented factors, should be distributed among those local 501(c)(3) agencies requesting funds to expand their capacity to serve the hungry and homeless. United Way administers the program in Westchester and Putnam, supports the local Board's decision-making process, and monitors the use of all funds allocated. In fiscal years 2008 and 2007, a total (unaudited) of \$398,152 and \$421,997, was granted and these amounts are not included in the statement of activities of the United Way.

18. Deficiency in Unrestricted Net Assets

The organization incurred a deficit of approximately \$932,000 in the fiscal year ended June 30, 2008. The deficit primarily resulted from a greater than expected non-cash expense associated with investment losses in the organization's defined benefit plan assets. The investment losses reflect general market conditions in fiscal 2008 and 2007, during which periods the plan asset allocation was 30% equities and 70% fixed income.. The deficit also resulted from lower than expected fundraising results, including an approximately \$908,000 decrease in the funds received through a coalition of United Ways in the tri-state region, over which the organization does not have direct control, and disappointing campaign results generally. The Board and management are taking steps to implement a more rigorous planning process in an effort to avoid a similar deficit in future fiscal years.

18. Deficiency in Unrestricted Net Assets *(continued)*

In particular, the Board and management, under the leadership of a new CEO and new Board Chair as of February 2008, have examined the operating budget in order to reduce costs and have implemented a new resource development and marketing strategy to increase unrestricted contributions from all financial levels of donors throughout all of the communities in Westchester and Putnam counties. In connection with these steps, the organization's current defined benefit pension will be frozen effective February 2009 (see Note 19), one of the organization's satellite offices will be closed, and the staff has been restructured to accommodate the new resource development strategy. In addition, the organization's community impact work is currently being re-focused and funding commitments related to initiatives are being more closely tied to the amount of unrestricted resources.

19. Subsequent Events

On November 19, 2008, the Board of Directors voted to freeze the benefits accruing under the defined benefit plan and plans to replace the plan with increased contributions to their defined contribution plan. The United Way is awaiting an estimate of the termination liability from the defined benefit plan's actuaries. Any unfunded obligation under the plan is expected to be funded over five years.

Subsequent to year end, the credit and liquidity crisis in the United States has resulted in substantial volatility in the global financial markets. As a result, the United Way's investment portfolios (including pension plan assets) have incurred a significant decline in fair value since June 30, 2008. However, because the values of the United Way's individual investments have and will fluctuate in response to changing market conditions, the amount of losses, if any, that will be recognized in subsequent periods, cannot be determined.
